**Scope of personal data processed, purpose and legal basis of data processing**

### How long do we keep personal data?

Personal data will be retained until the end of the hearing procedure at the latest, provided that, if the data subject has been contacted, the data processing will continue until the appropriate legal basis exists.

### Who has the right to view the personal data sent?

Personal data may only be disclosed to members of the professional jury.

### Rights of the data subject in connection with data processing:

- **request access to your own personal data**, i.e. information about what personal data the controller processes in relation to you, and request a copy thereof, provided that the rights of others are not adversely affected;
- request the **erasure of personal data**, unless the processing of the data is necessary for the establishment, exercise or defence of legal claims (in the case of aria recording, this does not apply to the video recording published by the data subject);
- **request restriction of processing of personal data**;
- **object to the processing of personal data at any time** for reasons relating to your particular situation. In such a case, the employer shall no longer process the personal data unless there are compelling legitimate grounds for the processing which override the interests, rights and freedoms of the data subject or for the establishment, exercise or defence of legal claims;
- **on the basis of the right to data portability**, the data subject shall have the right to receive personal data concerning him or her, which he or she has provided to the controller, in a structured, commonly used and machine-readable format and to transmit those data to another controller;
- contact the Data Protection Officer of the Data Controller directly;
- apply to a court (the competent court will decide on the claim);
